Outcome Highlights



80% of participants said completing myPrime was a good experience.



80% of participants completed myPrime with an understanding of, and being able to identify, low risk choices.



Behavioral intention around THC use shifted significantly. Before myPrime, 50% of participants intended to use THC. After myPrime, only 25% of participants said the same.

MyPrime is an online, host-guided, judgment-free approach to understanding how alcohol and drug-related problems develop and what we can do to prevent them.

Administrative Features

MyPrime offers program administrators ease of use and ongoing support. The PRI Team is always available to chat and to explore best avenues for meeting partners' prevention needs.

Program features include:

- Customizable registration process to fit your needs and requirements
- Access to user course progress and reporting, with simple filter and search features
- Completion notifications via email and dated participant completion certificates
- Anti-cheat features:
 - Automatic detection of video scrubbing blocks user access and provides instruction for resuming.
 - Participants must contact PRI to resume their course (no administrator response/support needed).
- Built-in participant support button
 - Connects participants directly to PRI for technical support
 - Typical response time to support tickets is less than 30 minutes
